## Methods of Payment for PMSC Subscriptions 2024/25

Subscription renewals are due from 1st November 2024 and must be paid in full by 31st December 2024.

The different options are detailed below. Whatever method you choose, please complete both pages and send them to the Membership Secretary via post or email.

### Method 1 By UK cheque

Please make your cheque payable **in full** to "Postal Mechanisation Study Circle".

### Method 2 Via Bank Transfer

When making any bank transfer, please state your name and the reason for the payment (preferably in the form e.g.: "<your name>, PMSC Subs 2024/25"). Note that the PMSC account is a Business Account.

**2A)** For transfers made from a **UK bank account**, the following will be required:

**2B)** For transfers made from an **overseas bank account**, the following will be required:

No charges are made if transfers are made internally within the UK. However, for transfers from overseas, it is possible that your local bank may impose a charge for the transfer. Please enquire and allow for any local bank charges and/or currency exchange charges with the payment you make – thanks.

### Method 3 Via PayPal (Overseas members only)

The PMSC does not formally operate a PayPal account. However, our Secretary (Jeremy Meal) is willing to accept a payment to his personal PayPal account for overseas members. Before doing so, please contact him at [jeremy.meal@btinternet.com](mailto:jeremy.meal@btinternet.com). **If paying by PayPal, the amount sent must include any extra for PayPal and any currency exchange fees so that the correct net amount due arrives in Jeremy's account.** Please do not send to any other member's PayPal account - thanks.

### Method 4 By cash (UK Sterling only, please)

This method should generally only be used if handing your subscription form personally to the Membership Secretary. Sending cash by post is not recommended due to the risk involved. However, should you choose to do so, please send me an email beforehand to say that you are paying by cash.

### Method 5 From your Personal Account (Overseas members only)

Individual PMSC Personal Accounts are now only held for Overseas members. The Membership Secretary will normally contact you during October to advise your existing Personal Account balance, **but just for this year the Secretary has obtained these figures in advance from Pat Nixon so Jeremy Meal will notify you of the amount you will need to pay, copying in Werner Ullah**, in order to renew your subscription for 2024/25.
